Preamble
The licenses for most software are designed to make sure you are free to share and change it. By contrast, the GNU General Public License is intended to guarantee your freedom to share and change free software to make it do what you wish for all your users.

This license, the Lesser General Public License, applies to some programs that are designed to be usable by an individual user. The purpose of this License is to ensure that the user is free to use the program (for private use only), and to share and change the software.

When we speak of free software, we are referring to freedom of use, not price. TERMS AND CONDITIONS FOR COPYING, DISTRIBUTION AND MODIFICATION

0. This License Agreement applies to any software library or other program which contains a notice placed by the copyright holder or other authorized party (the "licensor") indicating that it is licensed under this license, either in the form of a separate document or as part of the program itself.

Freedom
